### Bylaw 11/2024

# A Bylaw to Establish a Mail-in Ballot Voting System

The Council of the Town of Lanigan in the Province of Saskatchewan enacts as follows:

#### 1. Title

This bylaw shall be referred to as the "Mail-in Ballot Bylaw".

### Definitions

In this bylaw:

- (a) "Act" means The Local Government Election Act, 2015
- (b) "Declaration of Person Requesting Mail-in Ballot" means the declaration in Form C, Appendix A attached to and forming a part of this bylaw.
- <u>O</u> "Deputy Returning Officer" means the Designated Election Official appointed to initial and distribute the ballots to the electors.
- (d) "Election" means election as defined in the Act.
- (e) "Elector" means elector as defined in the Act.
- "Personal Care Facility" means a personal care home licensed pursuant to The individuals. Services Act, but only if the home or facility accommodates or cares for at least five Residential Services Act or an approved home as defined in The Mental Health Regional Health Services Act, a residential-service facility licensed pursuant to The Personal Care Homes Act, a special-care home designated pursuant to The
- "Regulations" means "The Local Government Election Regulations, 2015"
- (h) "Returning Officer" means the Chief Administrative Officer for the Town of Lanigan as per Section 47 of the Act and includes a Deputy Returning Officer who has been delegated any duty or power imposed or conferred on returning officers pursuant to
- $\equiv$ "Voters Registration Form" means the Voters Registration Form R, modified as required for in this bylaw, shown as Appendix B attached to and forming a part of this bylaw.

#### Purpose

The purpose of this bylaw is to establish a Mail-in Ballot voting process for the purpose of receiving ballots in an election.



- 3.2 Any elector who anticipates being unable to vote at an Advance Poll or on Election Day may apply to vote using a Mail-in Ballot.
- 3.3 Any elector who is receiving care in a hospital, personal care facility or similar institution situated within the Town of Lanigan, may vote in an election by mail-in

## 4. Mail-in Ballot Process

- 4.1 An application to vote using a Mail-in Ballot:
- (a) May not be submitted to the Returning Officer or other Designated Election Official in the case of a general election, prior to the Wednesday five weeks before nomination day.
- **b** In the case of a by-election, prior to the Wednesday five weeks before the nomination day.
- 0 Subject to 4.1(d) below, must be made in person and received by the Returning on the day immediately preceding Election Day. Officer for the Town or other designated Election Official on or before 4:00 p.m.
- <u>a</u> Where the elector is in a hospital or personal care facility or similar institution, such a request other Designated Election Official may attend that facility if the voter makes check the proof of identity in accordance with 4.2(c), the Returning Officer or in order to accept the documents required in Section 4.2(a) and (b) and to
- 4.2 Before being issued a Mail-in Ballot an elector shall:
- (a) Complete the Declaration of Person Requesting Mail-in Ballot form
- (b) Complete a Voter's Registration Form.
- Subject to 4.2(d), establish his or her identity and residence to the satisfaction proof of identity. Appendix D attached hereto and forming a part of this bylaw, shall suffice as forming a part of this bylaw), one piece of Voter Identification as listed in "Certificate of Identity and Residence" (see Appendix C attached hereto and administrator of the hospital or personal care facility completes the of the Returning Officer or Designated Election Official; if the facility
- <u>a</u> If the application is approved, the Returning Officer or other Designated Election Official shall enter the elector's applicable details in the Mail-in
- 4.3 A Mail-in Ballot Register shall be kept by the Returning Officer and shall include the following information:
- (a) The name and residential address of the elector;
- The temporary address of the elector (i.e. where the Mail-in Ballot is to be sent);
- (c) The telephone number and email address of the temporary address;
- (d) The date the Mail-in Ballot application is approved;



- (e) The date the completed Mail-in Ballot is sent to the elector;
- The date the completed Mail-in Ballot is received by the Returning Officer or other Designated Election Official;
- A notation whether the Mail-in Ballot was accepted, not accepted or spoiled;
- (h) Any other information considered appropriate by the Returning Officer.
- 4.4 As soon as reasonably possible after nomination day, the Returning Officer or whose name appears in the Mail-in Ballot Register: other Designated Election Official shall mail or otherwise deliver to each elector
- (a) A ballot for the upcoming election;
- (b) A ballot security envelope;
- (c) A voter confirmation envelope;
- A self-addressed, postage paid mailing envelope for the return of the ballot to the Returning Officer; and
- (e) Instructions for voting by Mail-in Ballot.

### 4.5 The elector

- (a) Shall vote in accordance with the instructions enclosed with the ballot; and
- (b) May vote for any number of candidates up to the number to be elected in the election in which he or she is entitled to vote.
- 4.6 An elector who has voted shall:
- Place the completed ballot in the ballot security envelope and seal the envelope;
- 9 Place the sealed ballot security envelope in the voter confirmation envelope and seal the envelope;
- <u>O</u> Date and sign the certificate on the voter confirmation envelope:
- Place the signed voter confirmation envelope in the mailing envelope and seal the envelope; and
- Return the mailing envelope to the Returning Officer by mail, courier or in
- 4.7 Upon receipt of the Mail-in Ballot the Returning Officer or other designated election official shall:
- (a) Record in the Mail-in Ballot register, the date and time the ballot is received;
- (b) Open the mailing envelope; and
- Remove the voter confirmation envelope from the mailing envelope, and place the envelope in a portable ballot box designated for Mail-in Ballot.
- 4.8 After the closing of the polls on Election Day, the Returning Officer or other Designated Election Official shall:
- Remove the sealed voter confirmation envelopes from the portable ballot box each voter confirmation envelope has been properly completed; designated for Mail-in Ballots, and determine if the certificate on the front of



- (b) If the certificate has not been properly completed, place the unopened voter confirmation envelope in a separate envelope for ballots that are not accepted;
- <u>ල</u> If the certificate has been properly completed, remove the sealed ballot sealed ballot security envelopes; continued this process until all voter security envelope from the voter confirmation envelope and place in a pile of confirmation envelopes received have been opened;
- (d) Remove all the Mail-in Ballots from the ballot security envelopes;
- (e) Insert the Mail-in Ballots into the vote tabulating unit;
- $\widehat{\Xi}$ Complete the vote counting procedures as specified in the Act
- Record in the Mail-in Ballot register whether the Mail-in Ballot was accepted or spoiled.

### 5. Receipt of Ballots

- 5.1 In order to be counted, a Mail-in Ballot must be received by the Returning Officer or other Designated Election Official by the close of the polls on Election Day.
- 5.2 Mail-in Ballots received after the closing of the polls on Election Day are deemed to be spoiled ballots.

# 6. Rights of Candidates and Agent

- The Voter's Registration Forms, Declarations of Persons Requesting Mail-in Ballots, or candidates' agents at the polling place on Election Day. and voter confirmation envelopes and certificates may be inspected by candidates
- 6.2 The candidates or their agents shall have the right to object to a person's entitlement to vote as per Section 112 of the Act.

# 7. Safekeeping of Election Materials

7.1 The Mail-in Ballots and forms and other election materials shall be retained and destroyed in accordance with Section 142 of the Act.

### 8. Effective Date

8.1 This bylaw shall come into force and take effect on the day of passing thereof.
