## BYLAW NO. 2/2025

## THE TOWN OF LANIGAN ZONING AMENDMENT BYLAW

## THE COUNCIL OF THE TOWN OF LANIGAN ENACTS AS FOLLOWS:

- The purpose of this Bylaw is to amend *The Town of Lanigan Zoning Bylaw* 5/2018 to accommodate residential development.
- The authority for this Bylaw is section 46 of *The Planning and Development Act, 2007.*
- 3 Schedule "A" of *The Town of Lanigan Zoning Bylaw 5/2018* is amended in the manner set forth in this Bylaw.
- 4 a) Chapter 8 –Maps are amended by re-zoning the lands described in this section and shown as outlined on the map attached as Appendix "A" to this Bylaw as follows:

- b) That Section 3 Administration is amended by deleting 3.11 Fees and replacing it with the following:
- "3.11 Special Provisions for Contract Zoning Agreements
- (1) A zoning designation which is subject to an agreement entered into pursuant to the provision of Section 69 of The Act shall be indicated on the Zoning District Map by the addition of the Bylaw number authorizing agreement after the zoning district designation."
- c) That the Table of Contents be amended by deleting 3.11 Fees and replacing it with the following:
  - "3.11 Special Provisions for Contract Zoning Agreements"
- d) That Table 7-4 RMH Manufactured Home Residential District Development Standards be amended by deleting the following:


